NOTICE OF NON-AD VALOREM ASSESSMENTS FOR 2026

Dear Property Owner:

The notice of proposed non-ad valorem assessments against your property for 2026 is attached to the bottom of your TRIM notice. "Non-ad valorem" means that the amount of these service charges is not based on the dollar value of your property, but on other factors. A combined tax and assessment bill will be mailed by the Tax Collector in November.

If you do not understand your assessment, or if you think an error has been made, please call the appropriate assessing body at the phone number listed below. You have the right to appear at a hearing or to file written objections with the local governing board within twenty days of this notice (twenty-five days for Solid Waste Landfill).

INDIAN RIVER COUNTY TAXING AUTHORITIES

Every taxing authority will hold a public hearing on their proposed budget. The size of the budget determines the millage rate and subsequently the amount of tax you will pay. Indian River County taxing authorities are listed below. Only those appearing on your notice levy tax on your property.

INDEPENDENT SPECIAL DISTRICTS There are four special districts.
1. Sebastian Inlet (321) 724-5175 Administers inlet and keeps it navigable.
2. Mosquito Control (772) 562-2393 Sprays, and manages impoundments to control mosquitoes.
3. Hospital District (772) 770-0935 Funds indigent care and other community health services.
4. Florida Inland Navigation (561) 627-3386 Dredges inland waterway.

WATER MANAGEMENT DISTRICT St. Johns River WMD (386) 329-4500 provides funding for conservation, dams, soil erosion, flood protection, and development of the river and its headwaters.

VOTER APPROVED DEBT This comprises one area.
1. Environmentally Sensitive Land Acquisition Bond - Funds up to \$50 million of environmental land purchases (County).
